I am a volunteer at Harbor Humane Society. I am aware that working as a volunteer for Harbor Humane Society involves risk of personal injury. I VOLUNTARILY ASSUME FULL RESPONSIBILITY FOR ANY INJURIES OR DAMAGES WHICH MAY OCCUR TO ME AS A RESULT OF MY PRESENCE AT HARBOR HUMANE SOCIETY. I ACKNOWLEDGE THAT MY SAFETY IS MY RESPONSIBILITY ALONE, AND NOT THE RESPONSIBILITY OF HARBOR HUMANE SOCIETY, OR ANY OF THEIR SUBCONTRACTORS, AGENTS, OFFICERS OR EMPLOYEES, AND THAT THEY SHALL NOT BE LIABLE FOR INJURIES OR DAMAGE, IF ANY, SUSTAINED BY ME ARISING OUT OF MY PARTICIPATION IN ANIMAL CARE OR MY PRESENCE AT THE ANIMAL SHELTER. I agree to follow all safety rules and procedures on the site. As a volunteer, I understand that I will not be paid or entitled to benefits of any kind, and that I am not covered under any Worker's Compensation law. I also agree that I am not a third party beneficiary of any agreement.

I, for myself and on behalf of my family, heirs, executors, administrators, personal representatives, successors and assigns, hereby fully and forever release, acquit and discharge Harbor Humane Society, and their respective officers, employees, agents, and subcontractors, and each of them (hereinafter collectively referred to as the "Releasees") of and from any and all actions, causes of action, suits, claims and demands of



and death, losses and damages, compensatory, exemplary and punitive, whether known or unknown, foreseen or unforeseen, resulting or to result from, or in any way related to, my participation in volunteer activities or the negligent acts or omissions of Releasees. I expressly understand and agree that this release and covenant not to sue is intended to cover and does cover not only all injuries, losses and damages which may be quickly apparent, but any and all future injuries, losses and damages which may later develop or be discovered, including all the effects and consequences thereof.

AFTER CONSULTING OR HAVING HAD THE OPPORTUNITY TO CONSULT WITH COUNSEL, I KNOWINGLY, VOLUNTARILY AND INTENTIONALLY WAIVE IRREVOCABLY, ANY RIGHT TO A TRIAL BY JURY IN ANY ACTION OR PROCEEDING IN THE EVENT OF ANY DISPUTE REGARDING THIS RELEASE AND COVENANT NOT TO SUE. I UNDERSTAND THAT I WILL NOT BE PERMITTED TO VOLUNTEER AT HARBOR HUMANE SOCIETY IF I DO NOT SIGN THIS RELEASE AND COVENANT NOT TO SUE. I AGREE TO THE TERMS OF THIS RELEASE AND COVENANT NOT TO SUE, AND ACKNOWLEDGE HAVING READ AND UNDERSTOOD ALL OF ITS TERMS.
